## Illinois Department on Aging (IDoA)

## PUNS/PAS/ISSA: Home-Based Waiver Services

"Home-Based Waiver Services are designed to support you in making progress toward and reaching desired outcomes, as documented in your Personal Plan. Services are also designed to keep you safe and well in your home or community. Funds are to be used for your support and <u>needs</u>."

#### PAS = Pre-Admission Screening

"The purpose of this program is to make necessary determinations regarding eligibility for services, to educate individuals and families in order to offer a choice of service arrangements, and to provide follow-up in a timely manner. The Pre-Admission Screening process collaborates with the consumer and his/her family and includes gathering relevant information to document the diagnosis of an intellectual disability, conduct assessments and evaluations, as well as the status of state and federal entitlements, and guardianship <u>status</u>."

#### PUNS Waiting List= Prioritization of Urgency of Need for Services

Serves as a waiting list for services and as a database state wide. By signing up for the PUNS waitlist, it ensures that the Department of Human Services and the State of Illinois is aware of your need for home based waiver assistance. PUNS agencies by <u>regions</u>.

<u>ISSA = Individual Service and Support Advocacy</u>

"The ISSA service is designed to assist but not supplant the guardian and other appropriate advocates in fulfilling their responsibilities. Additionally, the ISSA case manager serves as an independent resource for consumers and families to clarify issues with providers or services such as possible changes in support levels and conflict resolution. The ISSA staff participates in the development of the Individual Service Plan (ISP), approves the ISP, and monitors its implementation as well as the general health, safety, and well-being of the <u>participant</u>."

## Crisis Nursery

"The Department of Human Service partners with crisis nurseries service providers to meet the needs of families who experience short-term crisis. Six nurseries in Illinois currently provide respite and short-term care for some of Illinois most fragile families, many who experience crisis due to lost employment, medical emergencies, violence, and family dysfunction. The goal of the crisis nursery program is to reduce parental stress, change parenting skills, and reduce the risk of child maltreatment. The families served often need family stabilization, child abuse prevention or other critical support <u>services</u>."

## Mental Health Resources through DHS

"As the State Mental Health Authority, the DMH is responsible for assuring that children, adolescents and adults, throughout Illinois, have the availability of and access to public-funded mental health services for those who are diagnosed with a mental illness or emotional disturbance and an impaired level of functioning based on a mental health assessment. Service delivery in DMH is provided within <u>five geographically organized service Regions</u>, through 162 community mental health centers/agencies (called 'Providers'), 27 community hospitals with psychiatric units and seven state-operated hospitals, the latter containing both civil and forensic beds. The DMH also provides statutorily required treatment services for sexually violent persons through its Treatment and Detention <u>Facility</u>."
