

#### **About the Presenters**

Stephanie Altman Stephanie Altman directs the Shriver Center's work to uncover systemic inequities and create new pathways for opportunity through legislation and system changes. She also directs the organization's healthcare advocacy, representing clients in individual and class actions related to healthcare equity and advocating for accessible healthcare through administrative and legislative forums. Prior to working at the Shriver Center, she was the Programs and Policy Director at Health & Disability Advocates. Stephanie was also an Assistant Professor of Clinical Practice at the Chicago-Kent College of Law and worked as an attorney with the Legal Assistance Foundation. Stephanie was formerly on the board of and is the past Chair of Telligen, and was appointed to the National Quality Forum MAP Medicaid Child Task Force. She is also the past Chair of the Legal Aid Committee of the Chicago Bar Association. She was also on the Illinois Affordable Care Act Navigator Training Team and the Illinois Older Adult Services Advisory Committee. Stephanie earned her law degree from Loyola University School of Law and a B.A. from Grinnell College. She received the 2011 Loretta Lacey Child Health Advocacy Award, the Esther R. Rothstein Award in 2010 from the Lawyers Trust Fund of Illinois, and the Child Health Advocates Award in 2005 from the American Academy of Pediatrics. She was named a Trial Lawyer of the Year Finalist in 2006 by Trial Lawyers for Public Justice.

Kristin Hartsaw, MPH, MCHES is the Director of Training and Technical Assistance at the DuPage Federation on Human Services Reform. In this role, she conducts training on a variety of topics including *Navigating Public Benefits*, the *Influence of Culture, Mental Health First Aid*, and more. She has provided enrollment assistance to families applying for health coverage and served on the State of Illinois training team to deliver Health Insurance Navigator/Assister training. In addition to her work with the DuPage Federation, Ms. Hartsaw is an adjunct faculty member with the MPH Program at Benedictine University.

Jose Mendez a Benefits Advisor in the Chicago Regional Office of the U.S. Department of Labor's Employee Benefits Security Administration (EBSA). Mr. Mendez began his career with EBSA in 2010. Since then, he has assisted thousands of participants, beneficiaries, and benefit plan fiduciaries understand their rights and duties under the Employee Retirement Income Security Act (ERISA), ACA, COBRA, HIPAA which are the laws that protects the benefits of workers and retirees in private-sector pension and welfare plans. Rose has been a direct service provider to children who are blind, visually impaired, have Autism, deafblindness, and have mental health needs, as well as physical disabilities for 27 years, in various capacities. She strives to implement best practices in Early Education as well as adult services to all persons who qualify. Rose guides and encourages Families to become their own case managers, build their skills and abilities to transform their loved ones lives, to improve quality and opportunity, and build the capacity of communities that can support these people.

**Leonor Vanik**, Ph.D. is a sibling, to Maria who is an artist at Arts of Life, and a Latinx disability rights advocate at the local, national and international level. Leonor is an evaluation management consultant and researcher focusing on the social production of disability and marginalized spaces in the built environment and is currently working on disaster disability mitigation and culturally competent engagement. She has extensive experience working with non-profits, government, and foundations, and is the co-editor of the [forthcoming] Latinx Disability Reader.
