About the Presenters

Aetna Better Health, Illinois Medicaid Managed Care (MCO) : Mary Cooley, Bret Deyo, and Hector Barendt-Hernandez, the clinical leadership team for Aetna-BH Illinois MCO, have between them 50 plus years of experience in clinical innovation, promoting patient-centered care and 40 plus years in Medicaid Managed Care leadership. They are fervent advocates of supporting children with Medicaid and promoting health equity.

Ruth Aguilar has over fifteen years of combined experience advocating for people with disabilities. She holds a B.S Psychology from the Illinois Institute of Technology and Professional Graduate Studies in Non-Profit from Harvard University. Ruth's professional experience stems from working previously in an ISC Agency and then as a Self-Directed Assistant serving the community with intellectual and developmental disabilities. Moreover, with her personal expertise as a mother of a teen girl with Rett Syndrome and Seizure Disorder, Ruth brings a wealth of knowledge to the families by assisting them in how to obtain services and understanding their options by being assertive, yet professional. Ruth is inspired by her husband and her daughter to be a servant leader who helps those around her without hesitation.

Stephani Becker conducts policy research, data analysis, trainings and advocacy on a range of health care issues, including the Affordable Care Act (ACA) and access to public benefits. Stephani provides training and technical assistance on ACA implementation and Medicaid to navigators, certified enrollment specialists and community agencies in Illinois. Stephani also manages HelpHub, an online crowd-sourcing community of over 2,000 enrollment specialists in Illinois. Stephani is a founding member of the Protect Our Care Illinois coalition which was formed in January 2017 to protect against repealing the ACA and disastrous cuts to Medicaid. Prior to joining the Shriver Center, Stephani was Project Director of the Illinois Health Matters digital hub at Health & Disability Advocates. Stephani has an MPP from the John F. Kennedy School of Government at Harvard University and a BA in English from Duke University.

Jay Bohn began working for the State of Illinois Department of Public Aid KidCare Program (now AllKids) in 1999, then transferred to DHS-DDD in 2011. He is currently an analyst in the Medicaid Waiver Unit. Before his employment with the State, Jay worked for ten years in the private sector for Mental Health and Intellectual/Developmental Disability community residential agencies in Illinois and Oregon.

Andrea Kovach advocates for quality, affordable health care to be accessible to all Illinoisans. Andrea's work focuses on the successful implementation of the Affordable Care Act and on improving and defending the Medicaid program. Andrea employs the full advocacy toolbox at the direction of community. She is an Executive Committee and Steering Committee member of the Healthy Illinois Campaign (which works to ensure a pathway to affordable, comprehensive health coverage for all immigrants) and a co-chair of its Income Equity Working Group. Andrea convenes the Illinois Immigrant Access to Public Benefits Work Group and is an Executive Committee member of the Protecting Immigrant Families-Illinois (PIF-IL) coalition, created to educate and resist the former administration's harmful federal rulemaking. Andrea is also a proud participant in the Immigrant Health Academy and the Illinois Alliance for Welcoming Health Care Providers.

Josephine Mueller, Jack Myers and Megan Forristall are Public Affairs Specialists for the Social Security Administration. Together they have over 40 years experience with Social Security. They work together to cover the outreach needs for Social Security offices throughout the state of Illinois.

Faith Rosenshein Young has managed all aspects of care, including medical, insurance, educational, and vocational issues, for the past 25 years for her son who is Deaf-Blind plus. From 2020-2023 she was the Family Engagement Coordinator for Project Reach: Illinois DeafBlind Services. In this role she provided technical assistance to families of children aged 0 to 22 who have a combined vision/hearing loss and helped connect families with each other. Additionally, Faith facilitated collaboration between Project Reach and the Illinois Advocates for the DeafBlind (IADB) parent organization. Faith served nine years as the Governor's representative to the Illinois Advisory Board for Services for Persons Who are Deaf-Blind (IABDB). Her son receives services through the DHS-DRS Persons with Disabilities waiver.

Erica Stearns worked at The Arc of Illinois as an Illinois Life Span information Specialist for two years and is currently an employee of the Division of Specialized Care for Children (DSCC) . She is also the mother of two children receiving services through the DSCC's Medically Fragile Technology Dependent Home and Community Based Waiver. Prior to her employment at DSCC in the summer of 2023, she served as Chairperson of the DSCC Family Advisory Council as one of 22 family members across the state participating along with two DSCC staff members to bring together families and DSCC staff and leadership to promote the delivery of participant and family centered services.

Daniela Vélez-Clucas is a Healthcare Justice/Immigration staff attorney committed to social, economic, and racial justice. At Shriver Center, Daniela focuses on issues related to immigrant eligibility for health coverage, public charge, enrollment in Medicaid/Medicaid-like programs, like HBIA/HBIS, PHE unwinding and redeterminations, and other issues at the intersection of immigration law and- health care coverage. Prior to Shriver, Daniela worked as a supervising attorney at the National Immigrant Justice Center representing unaccompanied immigrant children and their families in an array of immigration matters. Daniela brings her lived experience as an immigrant herself and an immigration lawyer to further Shriver's mission.

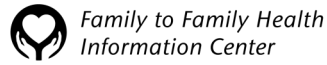

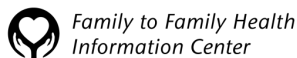
