# How Sydney uses Co-Pilot

- Helps edit emails to sound more professional.
- Brainstorms ideas for more slides.
- Looks over documents to see if there is a topic idea I'm missing.
- Can explain challenging words or metaphors someone says in a meeting.

# How Sydney Uses NotebookLM

- Uploads a document.
- Has it make a video or audio overview of the document to help me understand it or know what is missing.
- Creates flashcards about it.



# How Sydney uses Gemini AI

- Adds events and reminders to her calendar.
- Assists with challenges that arise with work.

- To help get ideas out when tired of typing.
